

PRIVACY POLICY

This Privacy Policy is applied to www.utip.info (the "Website") operated by **Individual Entrepreneur Sharin Evgeniy**.

UTIP Technologies Ltd, registered address 614015, Russian Federation, Perm Krai, Perm, 12 Monastyrskaya Street.

"We," "our" and "us" currently refer to **Individual Entrepreneur Sharin Evgeniy**.

We are committed to protecting and respecting your privacy. This policy (together with our Customer Agreement and any other documents referred to on it) sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

For the purpose of the Data Protection Act 1998 (the "Act"), the data controller is **Individual Entrepreneur Sharin Evgeniy**.

1. INFORMATION WE MAY COLLECT FROM YOU

1.1. Information we may collect from you includes:

1.1.1. information that you provide by filling in forms on the Website. This includes information provided by you while making an order on the Website;

1.1.2. records of the correspondence, if you contact us;

1.1.3. details of transactions you carry out through the Website and of the fulfillment of your orders; or

1.1.4. details of your visits to the Website including, but not limited to, traffic data, location data, weblogs and other communication data, whether this is required for our own billing purposes or otherwise and the resources that you access.

1.1.5. information we may request according to KYC and AML policy. This information can be found in the AML Policy.

1.2. We may also ask you to complete surveys that we use for research purposes, although you do not have to respond to them.

2. WHERE WE STORE YOUR PERSONAL DATA

2.1. The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers. Such staff maybe engaged in, among other things, the fulfillment of your order, the processing of your payment details and the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

2.2. Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to the Website; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorized access.

3. USES MADE OF THE INFORMATION

3.1. We use information held about you in the following ways:



- 3.1.1. to ensure that content from the Website is presented in the most effective manner for you and for your computer;
- 3.1.2. to provide you with information, products or services that you request from us or which we feel may interest you, where you have consented to be contacted for such purposes;
- 3.1.3. to carry out our obligations arising from any contracts entered into between you and us;
- 3.1.4. to allow you to participate in interactive features of our service, when you choose to do so; and
- 3.1.5. to notify you about changes to our service.

4. DISCLOSURE OF YOUR INFORMATION

- 4.1. We may disclose your personal information to any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries.
- 4.2. We may disclose your personal information to third parties:
 - 4.2.1. if we are under a duty to disclose or share your personal data in order to comply with any legal obligation, AML policy or in order to enforce or apply the Customer Agreement and other agreements; or to protect the rights, property, or safety of **Individual Entrepreneur Sharin Evgeniy**, our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.
 - 4.2.2. in the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets;
 - 4.2.3. if our or substantially all of our assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.
